## 56<sup>th</sup> Annual Yuma USBC Women's Championship Tournament

- The Yuma USBC Annual Championship Tournaments purpose is to determine the scratch champions for Team, Doubles, Singles and All Events in each division. A plaque and USBC chevrons will be awarded to the highest actual pinfall in each division in each event. In case of a tie, co-champions will be declared. and duplicate awards will be given. Cash prizes will be awarded on a handicap basis for each event per division, except for All Events. Prize ratio shall be (1-7 team, 1-10 dbls,sgls)**
- ELIGIBILITY:** Tournament is open to all female USBC certified bowlers who are members of the Yuma USBC association.
- AVERAGES:** Qualifying averages, in order of acceptability, shall be:
  - Highest 2010-11 book average of 21 or more games.
  - Highest current average of 15 or more games in the same league as of December 1, 2011 with written verification from the league secretary.
  - If none of the above, bowler will be assigned an average of 200.
  - No professional bowlers allowed.
  - It shall be the bowler's responsibility to verify the accuracy of there average (see USBC Rule 319(a))
  - USBC Rules 319a(2), 319d, and 319e will not apply to this tournament.
- Multiple Participation:** Bowlers may enter team and doubles events 4 times, however, not more than 2 players may bowl more than twice in team event and may not bowl with the same partner twice. Participants may only bowl singles and all events once. A competitors initial participation in the doubles/singles event, requires them to bowl both doubles and singles. A participant bowling a multiple doubles session will only pay and bowl for the doubles portion after the initial competition.
- When a bowler participates more than once in team or doubles, the first appearance in each shall count towards all events. All events includes the nine game total from bowling the 1<sup>st</sup> appearance in team, doubles and singles events.
- ALL EVENTS IS OPTIONAL AND WILL BE BOWLED ON A SCRATCH BASIS.** Any entrant not paying the optional all events fee shall not be eligible for *cash prizes* in that event. Separate Prize Fund to be distributed in each division. The bowler who places first in each division in All Events shall be entitled to an award regardless of whether they had paid the optional prize fee. The Overall All Events winner shall be given a special award by Yuma USBC. They are not entitled to any portion of the optional All Events prize fund unless they had paid the optional fee. All Events Prize ratio shall be at least one in ten.
  - Paid All Events are not transferable unless the substitute replaces the original entrant in all three events and the transfer is made by the tournament director or their assistants prior to time of the substitute's participation in any event.
- Handicap will be based on 90% of the difference between the entrant's average and 200 for singles, 400 for doubles, and 800 for team.**
- Substitutes:** Subs are allowed. The tournament director must be advised of all subs at least one hour before the scheduled bowling time, if possible. In case of an emergency, after a game has started, a sub, if one is available shall be allowed in team and doubles only. The combined scores are to count in either of these events. If no sub is available, only the actual number of frames bowled shall count. A sub, when replacing another bowler, must bowl the team/doubles/singles for the same bowler in order to qualify for all events, provided the all events is paid. A sub shall not be required to reimburse the original entrant with the entry fee or prize money.
- Any player or team arriving late shall begin play and the score shall count beginning with the frame then being bowled. If an entrant is late for the doubles event, the entrant present shall bowl there singles first. If the partner has not arrived by the time the singles event is finished and a substitute cannot be found, the entrant present shall be permitted to bowl there games in the doubles event in order to qualify for the All Events Championship.
- Any check, in payment for entry fees for this tournament, that is returned for non-payment will be assessed a service charge of \$20.00.
- DRESS CODE RULE: Entrants are expected to wear appropriate attire. Examples include collared shirts, slacks, neat jeans, jean shorts (no holes and not frayed), Capri pants, proper length\* skirts, skorts, or dress shorts. No t-shirts allowed unless identical shirts worn by the entire team. Prohibited attire includes, but is not limited to: headgear (allowed for medical reasons only), tank tops, halter tops, bare midriffs, spaghetti strap tops, low-cut necklines, etc., shirts with inappropriate or vulgar pictures or writing, bib overalls, jeans not neat, clean, or in good condition, workout attire, short shorts\*, short skorts\*, and short skirts\*. \*NOTE: Skirt, skort, and short hemlines must extend beyond bowler's fingertips when standing relaxed and arms are extended downward at the bowler's side. Failure to comply, bowler will not be allowed to bowl and cause for forfeiture of entry fees. Tournament director or designee's decision as to appropriateness of attire will be final.**
- The decision of the Tournament Director shall be final unless an appeal is made in accordance with USBC Rule 329. **PROTESTS MUST BE FILED IN WRITING WITHIN 24 HOURS.** After the tournament rules have been adopted, they may be changed prior to the start of the tournament by a two-thirds vote of the board of directors. The adopted rules must not conflict with USBC rules.
- All entries postmarked by December 31st, 2011 will have the opportunity to be drawn from a pool for a free team entry. One entry will be drawn at random and that winner will have their team entry fee refunded. Only those entries with team events will be eligible..
- If not specifically stated in these local association tournament rules, USBC tournament rules shall apply.
